# **LOCATION**

The property is centrally situated in Harbour Point Business Park, Little Island approximately 8km east of Cork city centre. Little Island is served by an excellent road infrastructure providing easy access to the city centre, airport, Waterford N25, Dublin M8 and the South Ring road network. Harbour Point is a large mixed use development of offices and showrooms. Little Island has become Cork's premier industrial/commercial location.

# **THE PROPERTY**


