LOCATION

The property is situated on the N25 main Cork/Waterford Road approximately 7km west of Youghal, 4km east of Killeagh Village and approximately 44km east of Cork city.

Youghal is located approximately 40km east of Cork city and it has a population of approximately 7,794 in the town and environs (2011 Census). Youghal serves the immediate and surrounding hinterland as a residential, employment, tourist and service location. It is a heritage town situated at the mouth of the River Blackwater and overlooking Youghal Harbour.

THE PROPERTY

The property comprises two detached commercial buildings including a restaurant and garden centre/ showroom situated on a site extending to approximately 2 hectares (4.94 acres). The secure site is fully finished with central tarmacadamed entrance driveway with landscaped/lawned areas and tarmacadam parking area for approximately 115 cars in total.

Restaurant

The modern purpose built restaurant extends to approx. 4,000 sqft and is contained in a single storey detached property with external patio seating area to the front and single storey extension to the rear laid out with ancillary staff and storage accommodation. The restaurant is fully fitted and is laid out with entrance foyer, reception with service counter, two open plan seating areas with total capacity for approximately 110 patrons, ladies and gents toilets, commercial kitchen fully fitted with stainless steel working areas, cold rooms and staff utility and storage area.

Garden Centre

The garden centre/showroom comprises approx. 10,991 sqft and is contained in a mainly single storey building with mezzanine incorporated in the main retail/showroom section and warehouse storage unit attached with concrete/hardcore surfaced enclosed yard to the side. There is a canopy to the front of the main building extending to approx. 8,000 sqft situated over concrete surfaced display area and there is an uncovered concrete display area extending further north of the canopy.
