Location

Description

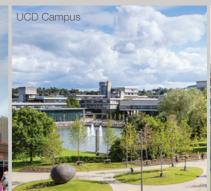
The property comprises a corner end of terrace two storey structure with single storey return.

Outside there is an enclosed rear service and storage yard with double gated vehicular access for deliveries.

The property forms part of a neighborhood retail parade adjoining a select Butcher and directly opposite a Spar convenience store.

There is shared off street parking for approximately 25 cars – 14 of which are directly fronting the property.

The property is currently in use as lock-up 7-Day licensed premises that is well laid out and in turn key trading condition. The ground floor incorporates a public bar, lounge bar together with toilet, service and storage facilities. The first floor comprises a lounge bar / bistro together with modern kitchen, toilet, service and storage facilities. There is office and storage accommodation to second floor level. The property enjoys the benefit of a timber clad sheltered beer garden / smoking area to the rear.

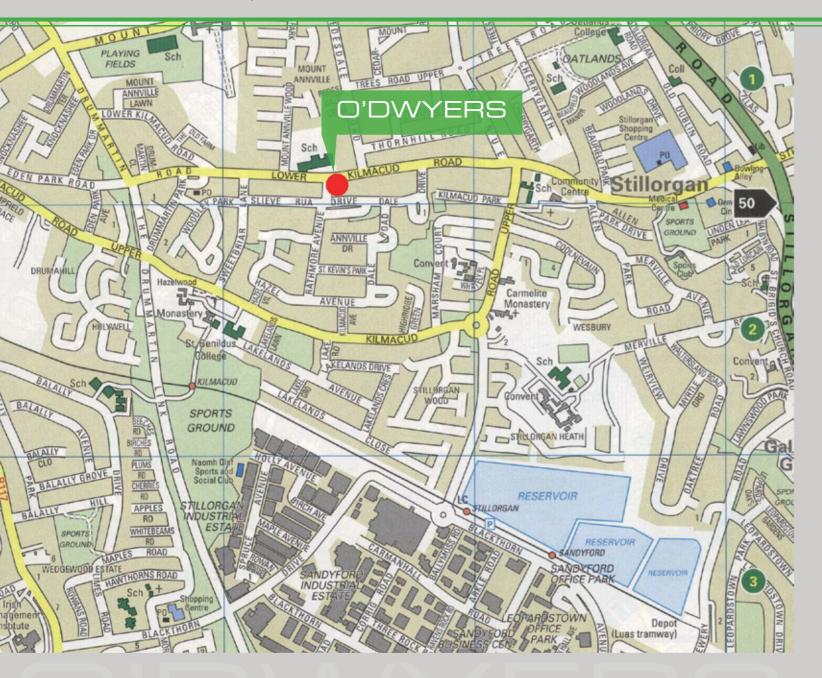

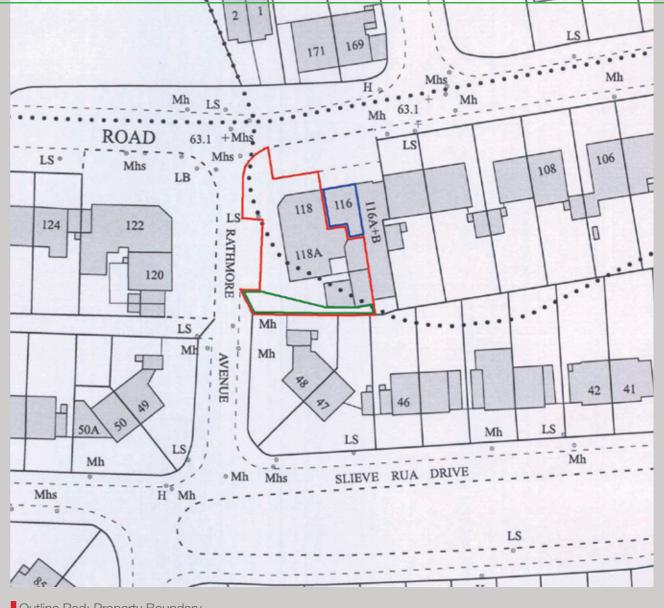
