The site is bound by various wooden and metal fences along the perimeter.

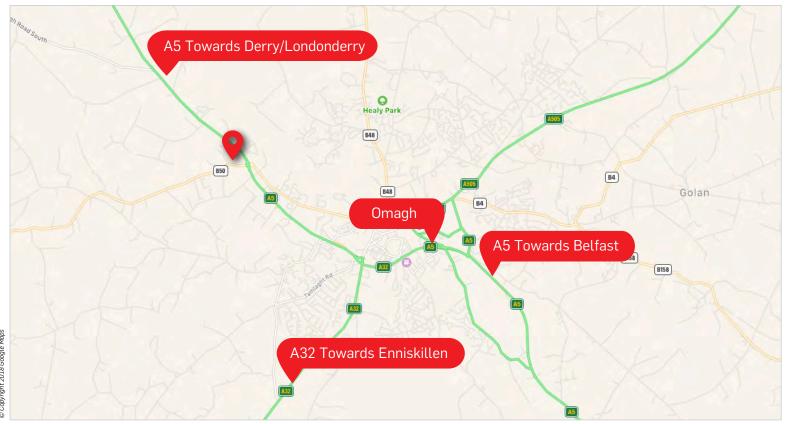
The land fronts the B50 Gillygooly Road and is accessed via a metal gate.
